

# **INSTALLATION INSTRUCTIONS**

Model: DOCK704-21010X-OX-12D

Rating: AC 125V, 60Hz, 12A

**Output:** Four 125V AC power outlets, 5V DC 4.2A USB charger with 4 charging ports, one Ethernet coupler, one HDMI coupler

## CAUTION:


### WARNING:

#### To reduce the risk of fire, electric shock or injury to persons

- 1. For indoor and dry location use only
- 2. Do not use with extension cord(s) to connect the unit
- 3. Do not install this device if there is not at least 10 meters (30 feet) or more of wire between the electrical outlet and the electrical service panel
- 4. Do not plug a device or devices into receptacles that exceed a total of 12A
- 5. Do not open or attempt to open the unit for any reason

### **MOUNTING:**

- 1. Bore a 7.91" x 7.95" (201mm x 202mm) hole on the desktop for mounting.
- 2. Put the DOCK-700 unit into the hole.
- 3. Place the mounting brackets through the included thumb screw. Tighten the screw by hand or use 4mm hex wrench to secure the DOCK700 to the desktop.
- 4. Plug power cord to the nearest wall outlet. Make sure the wall outlet is properly grounded.



Note:

Please install two wire management clip (not supplied) for the Ethernet or HDMI cable to leave enough play, and not interfere with the open/close movement of the dock.
