

# INSTALLATION INSTRUCTIONS

Model: DOCK701-11111X-XX-12S

Rating: AC 125V, 60Hz, 12A

Output: One 125V AC power outlet, 5V DC 4.2A USB charger with 2 charging ports,

one Ethernet Coupler, one Phone Coupler, one HDMI Coupler, one VGA Coupler


#### **WARNING:**

# To reduce the risk of fire, electric shock or injury to persons

- 1. For indoor and dry location use only
- 2. Do not use with extension cord(s) to connect the unit
- 3. Do not install this device if there is not at least 10 meters (30 feet) or more of wire between the electrical outlet and the electrical service panel
- 4. Do not plug a device or devices into receptacles that exceed a total of 12A
- 5. Do not open or attempt to open the unit for any reason

## **MOUNTING:**

- 1. Bore a 10.91" x 4.09" (277mm x 104mm) hole on the desktop for mounting.
- 2. Put the DOCK-700 unit into the hole.
- 3. Place the mounting brackets through the included thumb screw. Tighten the screw by hand or use 4mm hex wrench to secure the DOCK700 to the desktop.
- 4. Plug power cord to the nearest wall outlet. Make sure the wall outlet is properly grounded.



Note:

Please install four wire management clip (not supplied) for the RJ45 and RJ11 and HDMI and VGA cable to leave enough play, and not interfere with the open/close movement of the dock.
